# Hall of Fame Inductees

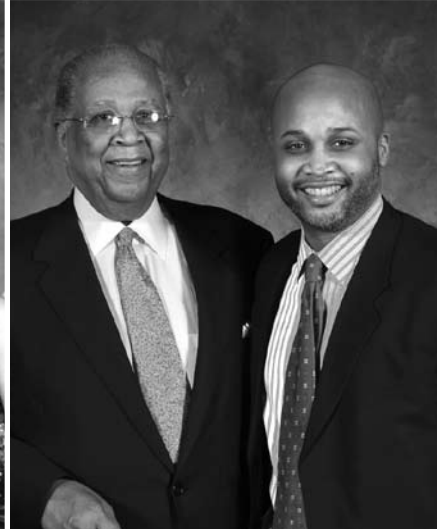
**Brad Edwards** and **Russell Perry** were inducted into the OAB Hall of Fame during the convention at the Friday night banquet attended by over 125 broadcasters and friends.

Since 1981, Mr. Edwards has been the extended public voice of those in need, but cannot be heard with his “In Your Corner” feature on KFOR. The former top-rated station news anchor has investigated

thousands of listener complaints including a massive expose’ of farmland pollution and government corruption that won him an Emmy. He has spearheaded station campaigns, “Warmth for Winter” and “Fans for Oklahoma.” Mr. Edwards was introduced by KFOR News Anchor and Hall of Fame member **Linda Cavanaugh**.

In 1993, Mr. Perry recognized the African American community in Oklahoma City was not being served by radio and acquired an AM daytimer, now KRMP. Since that time

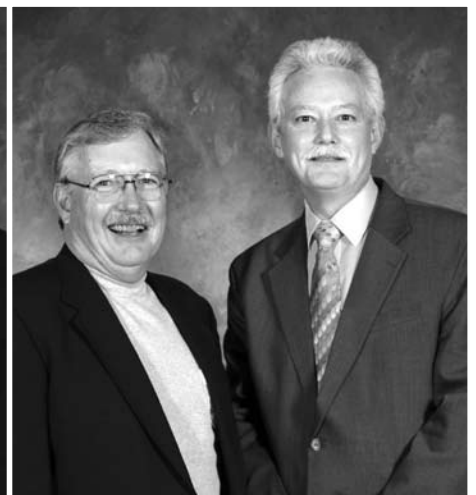
he has built the largest independently-owned radio group in Oklahoma with stations in Oklahoma City, Tulsa, Lawton, Duncan & Anadarko. His network of stations now reaches over 90% of the African American

community in Oklahoma. Mr. Perry was introduced by OAB Board Chairman **Wes Milbourn**.

Induction into the Hall of Fame is the highest honor given by the OAB. Messrs. Edwards and Perry certainly deserve to be a member of that select group of outstanding broadcasters.

## Digital Television Conversion— *What Now?*

With a hard deadline for the conversion to digital television, we now wonder what Congress has in store for us with legislation to be considered this session. House and Senate committees are expected to introduce their respective bills in the near future. This past session House Commerce Committee **Chairman Joe Barton**'s legislation provided for down conversion by cable of television's high definition signal to the delivery of standard definition to the consumer. The consumer would be prohibited from receiving the high quality television signal he had laid out big bucks for. It also, would have barred multicasting of the stations digital signal, thus restricting the choices the consumer would have and eliminating additional revenue streams. Barton's proposal would place our telecasters at the mercy of their gatekeepers, cable.

Also, the legislation did not provide adequate funds for the purchase of analog to digital converters for digital sets. This issue is really going to open a keg of worms in 2009 when all analog sets will require a converter. The government proposes allocating some funds for converter purchase, but it will be inadequate to fill the needs. There are a reported 232,000 homes in Oklahoma that receive television over-the-air without satellite or cable, and most are minority or impoverished households. Any analog set in your home will require a converter or can be thrown away. Many people are going to be upset for one reason or another.

Although there is no legislation at this date, the members of the Oklahoma Congressional delegation have indicated their support of broadcasters. **Senator Coburn** has voiced his opposition to government subsidies for converters.

## Representative Istook Comes Through

The Oklahoma House Congressional delegation is now 100% behind the legislation restricting satellite television to being a national service only. A few days after the convention, **Representative Istook** notified the OAB that he was going to sign-on as a co-sponsor of HR 998 "The Local Radio Preservation Act." Representatives **Sullivan, Boren, Lucas, and Cole** had already co-sponsored the bill.

Similar legislation, S 2418, was recently introduced in the U. S. Senate. The offices of Senators Inhofe and Coburn have been contacted regarding their support of 2418.

The House and Senate bills will prevent the satellite companies from carrying local content and restricts them to being a national service only as they were licensed and signed an agreement with the NAB.
